All memberships are valid for one year from the date of purchase
Cart fees are required from all players and are due at the time of play

Corporate Membership

River Falls Plantation and Village Greens Golf Club are pleased to announce their Corporate/Business Membership Program. The business must purchase at least (2) two membership cards (\$1,200 PER CARD) which will cover green fees at both River Falls Plantation and Village Greens Golf Club. This sum must be paid in full at the time of purchase. The membership card is fully transferable - when the membership holder is not using the card, it may be given to anyone they choose to cover their green fees. There are no monthly fees, no restaurant minimums, and no assessments.

Individual Membership

The rate for each individual membership is \$1,200 annually and covers the green fees at both golf courses. This option may be paid monthly at a rate of \$110 per month for 12 consecutive months and is non-transferable. You may pay an additional \$200 per year for walking privileges for the term of membership.

Family Membership

The rate for each family membership is \$1,900 annually and covers the green fees at both golf courses. This option may be paid monthly at a rate of \$195 per month for 12 consecutive months and is non-transferable. Family golf privileges are extended to husbands, wives, and dependent children 21 years of age or younger who reside with the family. You may pay an additional \$200 per year for walking privileges for the term of membership.

Junior and Senior Memberships

The rate for each junior and senior membership is \$600 annually and covers the greens fees at River Falls only. This sum must be paid in full at the time of purchase and is non-transferable. Junior golf privileges are extended to individuals the age of 17 years or younger and **can only be used Friday – Sunday**. Senior golf privileges are extended to individuals the age of 60 years or older and **can only be used Monday – Thursday**. You may pay an additional \$200 per year for walking privileges for the term of membership.

Driving Range Memberships

Individual Membership - \$600 annually (Members and/or Home Owners only)

Family Memberships - \$600 annually PLUS \$100 for each additional family member for one year Membership is for only one golf course. Please specify the course of your choice.
